We as citizens all have a connection and a responsibility to the land that our ancestors walked and lived on before us and a duty to pass that knowledge on to our youth who will be the future leaders of Delaware Nation. I have great confidence that our youth will cherish our heritage and do their part to honor, respect, and preserve it.

More now than ever we must protect our Sovereignty. Sovereignty gives us the authority to govern ourselves, we can determine tribal citizenship, and police powers, administer justice through our court, charter businesses, levy taxes, and the ability to protect our culture, heritage, and traditional knowledge and ways. Sovereignty predates the Delaware Nation Constitution as well as the United States Constitution and should never be taken for granted.

This year has been a year of fighting for our rights and protecting our Sovereignty. From educating academics on the Native American Graves Repatriation Act (NAGPRA) and why it is important to Delaware Nation, listening and discussing all the atrocities practiced at boarding schools, to going to Washington DC and asserting our Treaty rights.

My Grandmother and Grandfather attended Riverside in the '30s and '40s and never spoke about it. I would like to say to every citizen that had a relative attend boarding school, honor them by being the best, you can be.

I am honored to represent Delaware Nation as President and to uphold our cultural heritage by taking the necessary steps to preserve, protect and propagate our cultural heritage and economic sustainability.



LUKE BRENNAN



Delaware Nation is proud to officially introduce professional soccer player Luke Brennan, a 17-year-old Lenape athlete that is proud of his Native heritage & his Country. Luke Brennan currently plays for Atlanta United 2 in Atlanta GA and was recently called up to attend the USMNT U19 National camp in July 2022 in California. Native American Pro Soccer players are little to none. Here are the following pro soccer players according to Wikipedia, Chris Wondolowski – plays as a striker for San Jose Earthquakes and the United States national team, and is a member of the Kiowa tribe, Stephen Wondolowski - Former American Soccer Defender, Madison Hammond, Navajo & San Felipe Pueblo, is the first Native American to play on the National Women's Soccer League after signing with the OL Reign in 2020, and Harry Manson of the First Nations. Luke is the FIRST pro-Delaware Nation soccer player. He plays with his heart and soul and he loves every minute that he is on the Pitch. His dream is to be a professional Soccer player for the Premiere league and to represent his Native heritage at the highest pro level possible. Luke is not only a phenomenal athlete he is an outstanding person. He is loyal, intelligent, outgoing, and most importantly one of the nicest young men you will ever meet.Luke's history begins with his lineage: Grandmother Pearl Joyce Bedoka (Caddo/ Delaware), born and raised in Anadarko, Oklahoma with her siblings & parents, Louis Bedoka - Pearl Guy Bedoka. During "The Native American Relocation Act of 1956" Pearl Joyce Bedoka was relocated to Los Angeles to learn a trade and be removed from her native land and people. Pearl Joyce had to succeed in Los Angeles due to the fact she could not afford the moving expenses to return to Oklahoma. Amid her newfound life in California, she was married and years later had two children. Sadly, the marriage did not work out and Pearl Joyce had to raise two infants by herself in Los Angeles without any family to help or encourage the young mother of two. Years later, Luke's mother, young adult Shana Smith Brennan, left Los Angeles and moved to Atlanta, Georgia. There she met her husband Jim Brennan and had two boys (Luke Brennan & Jackson Brennan). Luke was introduced to soccer at the age of 2, while his older brother Jackson was competing in a church league. Luke was attending the game as a spectator, but he kept running onto the field and was determined to play. As a result, he received special permission to play at the age of 3 for the church league. At age 6, Luke joined a Club team with special permission and played for the U8s. From there he succeeded and went on to try out for an Academy MLS team "Atlanta" United Academy ". At the age of 11, Luke was 1 of 5 of the youngest players to receive an invitation to play for Atlanta United Academy Inaugural team in 2016. From that point on, Luke has played for Atlanta United Academy. He has made strides playing for Atlanta United Academy from the U12s to the U17s. He has been such a strong player at the age of 16 he was asked to join Atlanta United's second pro team (Atlanta United 2) as an unsigned pro. In August 2021, Luke started receiving recruitment calls and letters from every major D1 college from the West Coast to the East Coast. Due to Luke's loyalty and strong relationship with the soccer coach at USC (University of South Carolina) Luke committed to USC. In July 2022, Luke scored his first professional goal and received a call-up to USMNT (United States Men's National Team) for the U19s. Delaware Nation is proud to honor the incredibly talented tribal citizens that make this tribe great.





Brayden is a 19-year-old senior graduating from Anadarko High School. Brayden will play football for Southwestern College in Winfield, KS. On February 1, 2023, Brayden was honored at a scholarship signing ceremony that was held at Anadarko High School. Family, faculty, and friends joined to witness Brayden sign the scholarship to play for Southwestern.

He is eager to take his football career to the next level and was very grateful for everyone's encouragement in getting him to this point. He supports his tribe and honors his Native traditions.








REYNOLDS FRENCH SR.

My mother was Delaware, and my father was Caddo. I am retired and live in Norman, Oklahoma, with my two sons, Reynolds French Jr. and Michael French.

I graduated from Anadarko High School in May of 1960, then spent four years in the U.S. Air Force as a Radar Technician. I became a Vietnam advisor in 1964.

After the Air Force, I attended Cameron State Junior College in Lawton, Oklahoma, majoring in Electrical Engineering. I graduated from Central State University in Edmond, Oklahoma, with a Bachelor's and Master's Degrees in Education. I also attended Law School and was a Ph.D. Candidate in Educational Research and Program Evaluation at the University of Oklahoma.

My experience and employment have varied. I have worked as an Electronic Technician, TV Technician, Computer Technician,



and Lab Technician for several employers. I have also worked as a Veteran's Counselor for the Veterans Administration, Assistant Plant Manager for Altech Corporation, Educational Researcher at Oklahoma State University, Guidance Counselor for South OKC Jr. College, and a Social Worker for the Department of Human Services, State of Oklahoma.

Working with Native Americans, my first job in this area was for Oklahoma State University as Associate Director of Oklahoma Indian Educational Research. Next was for Oklahomans for Indian Opportunity (010) in Norman, Oklahoma. I did the Fort Sill Indian School Drop-Out Survey. This led to my employment as a Guidance Counselor at Ft. Sill Indian School. I also spent 12 years with Three Feathers Associates (TFA), a Native American Social Service Organization in Norman, Oklahoma as a Director of various Native American projects. The first project was to assist the Bureau of Indian Affairs (BIA) in setting up the Court of Indian Offenses/ Court of Federal Regulations (CIO/CFR) system for Western Oklahoma. We then assisted the Western Tribes of Oklahoma with setting-up individual Tribal

Courts, especially in the area of Indian Child Welfare. Other projects, on a national level, were training tribes and tribal organizations on the Indian Child Welfare Act; Native American Veteran's non-use of Veteran's Benefits; Development of Tribal/ State contracts; Federal Grant writing; Development of definitions of Native American Child Abuse and Neglect and a Public Service Video on Native American Child Abuse and Neglect. We also assisted with TFA's other national Native American projects including the Indian Head Start Program and the Indian Handicap Head Start national training programs.

My brother, Edgar French, Jr., and sister, Mary French Smith held many positions within the Delaware Nation and provided me with their knowledge and experiences. I have previously been the President of the Delaware Nation in 1993 and a Committee Person on the Executive Committee from 2012-13. It has been an honor and a privilege to be a member of the Delaware Nation and I will assist the Delaware Nation in any manner possible.

General Welfare Assistance Natural Disaster Program began on **October** 12. 2022: This program is funded by tribal RAED funds to eligible applicants on a one-time per fiscal year basis per person nationwide for \$3,000.00. CPAIN: CORPORATIONS POSING AS INDIGENOUS NATIONS

Corporations Posing as Indigenous Nations (CPAIN) is a national phenomenon where corporations will claim to be a representative of Indigenous peoples while having no ties to native communities. These corporations claim to represent the Lenape, among other Indigenous peoples.

These organizations vary in structure, sophistication, stated purpose, and funding. Yet all mask their theft of our Lenape history, spirituality, and culture within a robe of cultural preservation and unproven indigenous lineage. Some have even tried to claim the remains of our ancestors. Donors often donate money, land, and artifacts to CPAIN groups thinking they are giving back to an Indigenous Nation the land and artifacts were stolen from.

If a "pretendian" is an individual who falsely claims indigenous lineage, then CPAIN is what happens when a group of "pretendians" decide to form a corporation, usually a non-profit, and pass it off to the public as a tribe. One main reason this is done is due to financial gain. The CPAIN companies, being recognized as Indigenous Nations, can take advantage of federal funding through grants.

FINANCE

PURPOSE:

The Finance and Procurement Offices provide financial management and support while safeguarding the assets and ensuring financial integrity for the Delaware Nation. The primary responsibilities are to administer and provide accounting functions for the tribe's financial resources while utilizing best practices to stay in compliance with Tribal, Federal, and State regulations. It is always our goal to maintain confidentiality, transparency, and accountability.

CORE FUNCTIONS:

- Accounts Payable To control and monitor expenditures by obtaining the lowest cost possible with satisfactory terms and quality and by not allowing expenditures to exceed budgeted amounts.
- Accounts Receivable Ensure all collections and deposits of funds due to the Tribe are received and processed accurately.
- Audits Prepares and completes an organization-wide annual audit with no findings.
- Budgeting Assists in the budget development, monitoring, maintenance, and reporting of all Delaware Nation budgets.
- Fixed Assets Provides necessary recording and tracking of fixed assets acquired.
- Grants & Contracts Financial Management Grants & Contracts are an important element of funding and they are subject to various audit and reporting requirements for pre-award, during, and post-award.
- General Accounting Provides reports, reconciliations, journal entries, and analysis.
- Internal Controls Maintains and adheres to proper controls, separation of duties, policies, and procedures and follows approval processes to safeguard financial resources.
- Payroll Accumulates employee and committee members' work hours, and calculates pay amounts and withholdings accurately and timely to the appropriate grant, contract, or tribal program. Provides governmental reporting as required.
- Procurement Provides fair and cost-effective acquisitions of goods and services by analyzing vendors for the best price for high-quality supplies.



TAX COMMISSION PURPOSE:

The Tax Commission provides Tribal revenue for the expansion of Tribal Government operations and services and enhances Tribal sovereignty by enabling Delaware Nation to regulate business activities on the Tribe's land. Since the last report 249 new tags have been issued and 688 renewals were processed. The total motor vehicle revenue from April 1, 2022, to March 31, 2023, was \$ 73,008.20. Casino vendors for Casino Oklahoma totaled 10 with a total machine count of 610. Casino vendors for Gold River Casino totaled 9 with a total machine count of 432. Below is the current FY23 amount of revenue collected for each casino:

CULTURAL PRESERVATION

MISSION:

The purpose of the Cultural Preservation Department is to protect, preserve and perpetuate the language, culture and heritage of the Lenape People by teaching, sharing and applying the values that have been handed down and taught by our elders to the present and future generations through discussions, song, crafts, regalia, dance and the arts.

ACTIVITIES INCLUDED:

For this Fiscal year we have had the following Cultural Classes:

- October November: Fall Drum Class
- December- Annual Tribal Christmas Dinner
- February to March: Women's Ribbon Skirt classes
- April: 2nd round for Ribbon Skirt classes
- April: 2023 Cultural Preservation Spring Powwow

In addition to our Cultural Classes, we were also able to participate in the Anadarko Downtown Business Trick or Treat event.

NEW GRANTS RECEIVED:

To date, we have received the following grants:

- Oklahoma Humanities Grant
- National Endowment for the Arts Grant
- BIA Living Languages Grant
- ANA Integrational Learning grant

The Oklahoma Humanities grant and BIA Living Languages grant will provide a total of 7 Lenape Picture books with Corresponding picture book YouTube Videos, an Alphabet coloring book, a number coloring book as well as produce a Lenape Vocab Builder App in the coming future. These are important first steps in the reawakening of the Delaware Nation Lenape Language.

We will have support from The Language Conservancy (TLC) to help implement beginner language education to help train in Lenape pronunciation using archival resources. The ANA Intergenerational Learning grant is geared towards our Early Childhood Learning Center and the introduction of the Lenape Language to our enrolled children at the center.

The purpose of the National Endowment for the Arts grant is to help support personnel and to help aid in the cost of supplies, marketing, artist stipends, etc. with the hopes of continuing and preserving our Cultural knowledge as a tribe and community.

We are always seeking Elders and Tribal citizens that are interested in sharing their Cultural Knowledge. If you have anything culturally related that you would like to share such as stories, pictures of family, art, regalia, beadwork, recipes, etc. please feel free to call or come by the Cultural Preservation Department.

HISTORIC PRESERVATION OFFICE

MISSION:

The purpose of the Delaware Nation Historic Preservation Office is to preserve the culture, language, history, ancestral lands, sacred sites, objects of cultural patrimony and materials and objects possessing ongoing cultural significance to the Delaware Nation through education, communication and consultation with local, state and federal agencies and organizations.

PROGRAMS:

Currently, our office maintains a Section 106/Tower Construction Notification System (TCNS) Program, Native American Graves Protection and Repatriation Act (NAGPRA) Program, Archive Program, Museum, Public Access Library/Gift Shop, and an HPO Extension Office in Pennsylvania.

SECTION 106:

The National Historic Preservation of Act of 1966 requires that Federal agencies consider the effects of their undertaking on historic properties and consult with Native American Tribes and Native Hawaiian Organizations on those potential effects. Our office consults on projects located within our 17 states of interest that cover our ancestral lands and removal routes to Oklahoma. Through government-to-government consultations and when needed, on-site monitoring, our office can protect our ancestral lands from destruction or damage of our sacred sites, such as cemeteries, ceremonial locations, archaeological sites and the flora and fauna of historic importance to Delaware Nation. Our office consults on and reviews over 600 projects per month.

TCNS:

The TCNS system was created by the FCC to allow for a streamlined system for Tribal consultation on proposed communications tower construction. This system allows our office to respond directly to the companies or entities providing notification of a project within our areas of interest. Our office handles close to 300 cell tower project consultation requests per month. This year we hired our new TCNS Coordinator, Tiffany Martinez. Along with TCNS requests, Tiffany has sorted through hundreds of files in our storeroom to clear and maximize our space for better storage of artifacts and archives as we work to digitize and preserve our collections.

NAGPRA:

Our office consults on the repatriation of Delaware/Lenape ancestors from museums and universities across the nation. Consultations with these institutions consists of frequent

meetings with the institutions to gather information regarding the ancestors and the places in which they were removed from their resting places. This information helps us to find and establish a proper place of final resting so the ancestors can continue their journey home. Consultations and the repatriation process can take up to 2 years or longer to complete. This year our office is concurrently consulting with 20 different institutions and museums on NAGPRA cases. In spring of this year, we completed one repatriation with Princeton University in a joint effort with our sister tribes, Delaware Tribe of Indians and Stockbridge-Munsee Community. With the most recent changes in the NAGPRA regulations, we estimate that our NAGPRA consultations will double in the next year.

HPO EXTENSION OFFICE:

Katelyn Lucas serves as Delaware Nation's Tribal Historic Preservation Officer, handling Section 106 reviews for Lenape homelands and assisting with NAGPRA and other historic preservation work. She manages Delaware Nation's extension Historic Preservation Office in Pennsylvania, which facilitates our access to the ancestral homelands and allows us to more effectively respond to historic preservation related projects and concerns in the surrounding region.

As of December 2022, Delaware Nation officially re-established our Tribal Historic Preservation Office (THPO) status with the National Park Service and the U.S. Department of the Interior. The National Park Service (NPS) Tribal Historic Preservation Program reviews and approves applications from federally recognized tribes to establish THPOs under Section 101 of the National Historic Preservation Act, and enters into Memoranda of Agreement with approved tribes. Katelyn Lucas initiated this process on behalf of Delaware Nation's historic preservation office last year, and President Deborah Dotson signed our approved MOA confirming Delaware Nation's ability to assume THPO responsibilities. Katelyn Lucas has been named Delaware Nation's Tribal Historic Preservation Officer who will, along with Historic Preservation Director Carissa Speck, continue the tribe's efforts to identify and protect historic and cultural resources in Lenape homelands and across our states of interest along Delaware Nation's forced removal pathway.

Delaware Nation has established an MOU with Lehigh University (Bethlehem, PA) and their Institute for Indigenous Studies (IIS) to move the extension historic preservation office

to Lehigh's campus. Delaware Nation will still maintain their relationship with the Museum of Indian Culture in Allentown, PA, but the museum's weekend only operating hours were incompatible with the daily functionality of the historic preservation office. Housing the historic preservation office on Lehigh University's campus allows for normal weekday operating hours, and also increases access to resources like academic experts in different fields including the Indigenous faculty at the IIS, research facilities and/or equipment, and student internships as well as opportunities to advocate for additional resources like scholarships for Delaware Nation students, educational speaking platforms and conferences to bring more tribal citizens to Lenape homelands.

Throughout this past Fall 2022 and Spring 2023 Katelyn has given multiple educational talks on Lenape history, land acknowledgments, and current events—often in collaboration with Delaware Nation tribal citizens—to institutions including Lehigh University (Bethlehem PA), Muhlenberg College (Allentown PA), Lafayette College (Easton PA), the University of Pennsylvania Museum of Archaeology and Anthropology (Philadelphia PA), and Davis High School (Oklahoma). Through these talks, she has helped make significant breakthroughs in spreading visibility and awareness of Delaware Nation and Lenape history in Lenape homelands. The aim of these educational talks is to hopefully increase future consultations and collaborations in the region which create more funded opportunities for tribal citizens to return to and have their voices represented and heard in Lenape homelands.



Lehigh University in Bethlehem, PA where Delaware Nation's Extension Office for Historic Preservation will reside and our THPO, Katelyn Lucas, will be working.

ARCHIVES:

Our office collects, describes, preserves, digitizes and stores any objects, materials or photos related to Delaware Nation history or culture. Delaware Nation tribal citizen, Billie Anderson, serves as our archivist and within one year has processed 770 folders of digital archives which was a total of 36,291 files. These digital files included scanned photographs, documents, books, and letters; including digital images and

audio language recordings. Billie is currently working on cataloging our physical artifacts to prep them for digitization. One of our preservation grants, which we just completed, was awarded by the Oklahoma Historical Society and funded a project that helped us digitize, preserve and protect our unique and very important collection of archives. With this grant, we were able to save thousands of photographs and documents retelling the story of our people. We found letters written long ago telling personal stories of lived experiences. While working on this project, our archivist went on a very personal journey as she discovered photographs of her grandparents and family members. She experienced moments of joy coming across these images and would share stories each time she found something new that reminded her of a memory she has with her grandparents, or a story that she had heard from a family member.

Another grant, from the Administration for Native Americans, was awarded to have our language audio recordings digitized from cassette tapes and CD's to digital files. Billie was able to hear her great-great grandmother's voice for the first time through listening to these recordings and she is so excited to be able to share that type of experience with our tribal citizens. She is also looking forward to bringing in our elders and sharing these recordings with them, to learn from, and to start teaching our youth.

Our goal is to have our entire collection of archives and artifacts completely digitized and properly cataloged to then be made accessible to our tribal citizens, in a new museum and library facility that will help preserve and protect our history and culture as Lenape people, and as the Delaware Nation.

LIBRARY/GIFT SHOP:

The mission of the Joan Subieta Memorial Library is to meet the informational needs of the Delaware Nation and surrounding communities, to inform the tribal members and the community of resources and services available, and to serve the recreational, informational and cultural needs in this geographic area.

The library is currently located in the Tamanend Building and Gina Smith serves as our Librarian. As of now, our library holds over 6,500 books, magazines, newspapers, audio cassettes, DVD's and other library materials. Interlibrary loan materials are also available and are provided through the Oklahoma Library Network. The library provides numerous activities and services for all ages such as public access to computers with internet and a printer/copy machine for those interested in making or updating resumes, applying for jobs online, applying for FAFSA, applying for Social Security and setting up and checking email.

The library has a wide variety of fiction, non-fiction and reference materials for checkout and in-house use. Some works of fiction we have include: There, There by Tommy Orange: Where the Crawdads Sing by Delia Owens; Remarkably Bright Creatures by Shelby Van Pelt; Boys from Biloxi by John Grisham; The Maid by Nita Prose; Little Fires Everywhere by Celeste Ng; all 18 of the Tony Hillerman mystery series featuring Navajo police officers Jim Chee and Joe Leaphorn; and Where the Dead Sit Talking by Brandon Hobson. In non-fiction we have a large selection of Native American/Indigenous authors on subjects like boarding schools, cookbooks and stories such as: Killers of the Flower Moon by David Grann; Yellow Bird by Sierra Crane Murdoch: The Sioux Chef's Indigenous Kitchen: American Indian Cooking; New Native Kitchen; and Frybread Past, Present & Future. We have also received a shipment of new books from the RoadRunner Press, all written by Oklahoma authors featuring children's fiction, non-fiction, and adult fiction/non-fiction books. We invite you to come in and browse the library, stay for a while and relax. All are welcome! The Gift Shop is located in the library and has a variety of Delaware Nation items for sale such as t-shirts, lunch-bags, mugs, etc. with many more items to come! You can also purchase Delaware Nation's Pendleton blankets. Orders can be made in person, online or by phone. Gina is happy to help!

FUTURE NEW OFFICE/LIBRARY/MUSEUM:

The Historic Preservation department will be moving to a new facility in downtown Anadarko located next to the Cultural Preservation building. The new facility will be home to our tribal museum and library, open to the public to provide services to our tribal citizens and local community. The renovation of the building has been partly funded by the ARP Indian Community Development Block Grant (ICDBG-ARP). The Historic Preservation department has also been awarded a grant from the National Park Service to fund interactive kiosks for display in the museum to serve as digital exhibitions and provide access to our digitized collections. Another grant from IMLS was awarded for the digitization of artifacts through 3-D photogrammetry imaging in partnership with the OU libraries emerging technologies team to help create digital 3-D models of our physical artifacts which we can then display with our interactive kiosks. These digitization projects ensure that our cultural and historical artifacts and archives are preserved and maintained through the future so that our stories and experiences continue to persevere and are not lost to time. As keepers of our own indigenous knowledge, it is imperative that younger generations of tribal citizens have access to our language, culture and history, just as our ancestors have done from time immemorial, so that collectively, Delaware Nation may live on.

MISSION:

The purpose of "Our Children's Garden" is to provide quality child-care for children 6 weeks to 48 months with safe and consistent care during Childcare, in a warm, friendly atmosphere with trained child-care professionals.

STAFF TRAININGS:

Each new staff member is required at minimum Entry-Level Child-Care Training (ELCCT), CPR First Aid, Food Handlers, Civil Rights (for CACFP), Reporting and Recognizing Child Abuse, Preventing the Spread of Blood borne Pathogens, Safe Sleep (SIDS).

Our Children's Garden, LLC is now a 5-STAR facility; therefore, all teaching personnel are required 30 training hours a year for their Professional Development Ladder (PDL) and all Directors are required 40 training hours for PDL and Oklahoma Directors Credential (ODC).

Once a month we offer a meeting for parents to come learn new and different material. We have a tentative schedule set for the remainder of the year.

The Lenape Police and Security Department's mission is to uphold the sovereignty and customs of the Delaware Nation, to protect life and property, and to promote and preserve peace within our community.

GOALS:

Professional service and community safety are the primary goals of this department. To achieve these goals, each officer must pass required background checks and commit to ongoing professional training to enhance their skills.

- Sexual Offender Registration and Notification Act (SORNA)

- Security services for all Delaware Nation events.

INFORMATION TECHNOLOGY

The Information Technology Department oversees the installation and maintenance of all Delaware Nation's computer network systems. The department's primary function is to ensure that the infrastructure's network runs smoothly.

IT Department responsibilities include, but are not limited to:

- Desktop Support
- Help Desk
- Systems Engineering
- Network Engineering
- Application Management
- System Administration
- Network Administration
- Project Management

TECHNICAL SUPPORT:

IT provides technical support to the organization's employees and trains non-technical workers on the business's information systems. We assess the effectiveness of technology resources already in use or new systems that are being implemented and determine the practicality of changes and modification of systems. The department also works with external partners, including consultants, agencies and vendors to arrive at the most appropriate system or integration of multiple systems.

COMPLIANCE:

The department utilizes the most current hardware, software and updates to maintain a healthy infrastructure and to prevent data breaches. High-profile data breaches remind us all that data security is a top priority for any business or organization. Our department adheres to current network compliance and security concerns.

ASSET INVENTORY:

Having visibility of what hardware and software assets we have in our network and physical infrastructure helps us gain a greater understanding of our security posture.

E-CYCLE EVENTS:

Through the guidance of Environmental Programs, E-Cycle events are held each year to recycle out-of-date office hardware such as computer desktops, laptops, monitors, printers, keyboards, mouses and much more.

NTIA BROADBAND GRANT:

This year, the IT Department has been busy working on the largest grant thus far awarded to Delaware Nation. This grant had several components, laptops, telehealth services, and high-speed broadband internet. This grant has allowed us to provide laptops with Microsoft Office for all tribal citizens 18 to 59. We are also in the process of installing a guest WIFI system at all of our sites to allow a place for citizens to have access to high speed broadband internet. This also gives tribal citizens who qualify and apply for the telehealth services that do not have home internet or perhaps a slow connection a place that they may be able to utilize those services by connecting to our high-speed WIFI.

MUSEUM AND LIBRARY RENOVATION PROJECT:

The IT Department is currently working with our contractors on the new downtown library and museum. We excited that we will have an easy to access location for tribal members to visit and enjoy the ability to see and access our cultural artifacts, histories, and guest WIFI.

NEW TECHNOLOGIES:

As technology advances and the modern workplace evolves our IT Department has sought to implement technologies that allow us to fit in this ever changing landscape. With the need for a more fluid work environment, as employees may have the need to work from home or from locations outside of our physical sites, the IT department has started to implement cloud-based software. Our Finance, department can now work more efficiently from anywhere with our new Abila software, and with the addition of Microix we have that same ability for our purchasing and payroll workflows. We have also purchased new switches for our network infrastructure. This will allow us to have more control and segmenting power between our departments for added security. We will be introducing a new phone system along with these new switches that further our ability to work in this fluid environment. We will be able to receive and return calls, send a fax, or listen to voicemails even if we are not currently in office.

FAMILY & SOCIAL SERVICES

TRIBAL ASSISTANCE PROGRAM (TAP):

The Tribal Assistance Program (TAP), formerly the 10% program, aids tribal citizens nationwide with general welfare programs once per fiscal year (Oct. 1-Sept. 30). Tribal citizens may choose one of the following benefits: food (\$300.00); clothing (\$300.00); or a utility payment (up to \$300.00). The eyeglasses assistance (up to \$400 every 2 years) is only for tribal citizens ages 0-59 years old.

ELDER CARE HEALTH PROGRAM

Elders (age 60+) are enrolled into Delaware Nations Elder Care Program. This program is funded with 15% of the Revenue Allocation Economic Development Plan (RAED). Assured Benefit, our third-party administrator, will mail out a card to the tribal citizens upon their 60th birthday. This is our 1st year in the program and many of the 273 elders enrolled have used this program to pay for medical, vision, dental and other eligible expenses. The funds dispersed each year remain on the individual card account and if not completely spent, will roll over with the new distribution. Our department is to assist the tribal elder when they have questions or cannot reach the third-party administrator's representative.

HEALTH ASSISTANCE PROGRAM:

The Delaware Nation Health Assistance Program is a nationwide dental and prescription assistance for Tribal citizens ages 0-59 years of age. The dental program is a one-

time fiscal year assistance up to \$1,000.00 that is not covered by Medicare, Medicaid, private insurance or Indian Health Services. The prescription program is available one-time per fiscal year up to \$500.00.

EDUCATION ASSISTANCE:

Delaware Nation Tribal Assistant Program provides funding for the following educational programs:

- 1. The Secondary School Incentive Program is designed to reward good grades and attendance for tribally enrolled students 5th-12th grades nationwide.
- 2. The Education-HS/College Program is designed to reward students who obtain their diploma for High School or College bachelor's degree or higher nationwide.
- The Adult Vocational Program provides financial assistance, including tuition and eligible stipend, to tribal citizens for training needed to obtain or enhance job skills, or to obtain a General Education Diploma (GED) nationwide.
- 4. The Higher Education (Pell Eligible) Program provides tuition assistance to tribal citizens enrolled in college full-time (12 hrs.+) to obtain an undergraduate degree. Students must maintain at least a 2.5 GPA.
- 5. The College Financial Assistance Program is also nationwide and provides financial assistance with various

- college related expenses and is available for tribal citizens enrolled full-time (12 hrs.+) and maintain at least a 2.5 GPA.
- 6. The Higher Education Pell Ineligible Program is available nationwide to tribal citizens enrolled in college full-time (12 hrs.+) who are not eligible to receive Pell Grant assistance while obtaining an undergraduate degree. Students must maintain at least a 2.5 GPA.
- The Lenape Wise Program provides tuition assistance to tribal citizens nationwide enrolled in college for the summer session, part-time or obtaining their postgraduate degree. Students must maintain at least a 2.5 GPA.
- 8. The Graduation Stipend Program is available nationwide to High School or College Students who have graduated in the current fiscal year.
- The College Prep Program is available nationwide for High School students in 10th to 12th grades to receive assistance with the cost of ACT/SAT test prep in person or online.
- 10. The Direct Employment Assistance Program provides a daily stipend for gas and lunch for newly hired tribal citizens to assist with gas and lunch costs until their first pay check is received. This program can also assist with obtaining required tools or uniforms for new employment.

COMMUNITY SERVICE BLOCK GRANT

Delaware Nation is awarded this grant to provide assistance to our elders and youth. The total award for this year is \$1,221.00. For the elders, Delaware Nation provided 37 turkeys at the Annual Elder Turkey Giveaway in November 2022. The remaining funds will be used to fund a youth activity during the American Indian Exposition.

Childcare & DEVELOPMENT FUND (CCDF) PROGRAM

Delaware Nation's Childcare and Development Fund Program is responsible for Childcare assistance to any "Indian child" ages 0-13, enrolled in or eligible for enrollment with any Federally recognized tribe living in the current designated service area of Caddo, Canadian, Cleveland, Comanche,

Cotton, Grady, Kiowa and Oklahoma counties. This program provides quality spending for Childcare providers, community outreach and covers the administration costs in operating this program. Delaware Nation currently provides Childcare payment assistance to 34 families. Delaware Nation CCDF offer offered a special Essential Workers Childcare payment assistance to 51 families in the Delaware Nation service area affected by COVID-19.

Delaware Nation uses CCDF funding to co-sponsor a Native Summer Learning Camp with Caddo Nation, Comanche Nation, Kiowa Tribe, and Apache Tribe. This camp is a 7-week program in which children gain cultural knowledge from a fully native staff in literature, stem, culture, healthy lifestyles, and art.

Currently, Social Services has two temporary Self-Governance ARP Programs available. The Elder Home Fuel Assistance is a nationwide elder program for home fuel costs up to \$500.00 while funding is available. This can be for propane, gas, or electricity. Payments are processed until the \$500.00 limit is reached. Elders must be 60 years of age or older to apply. The Emergency Household Water and Wastewater Needs Program is nationwide assistance for water/sewer services in need of restoration, new services, or past due balance at risk for disconnection. This is a one-time assistance of up to \$500.00 which can include reconnect fees and late charges.

I have the pleasure to work closely with Tribal Administration, Finance, Department Directors, our Grant Writer, Joel Haspel, and on occasion the Tribal citizens.

Each Director understands the needs of their department and oversees the day-to-day management of department grant awards. Many of the grants have a multi-year date of service. Budgets are created that reflect the dates of service allowed. On a department director's request, I provide the technical support needed to ensure programmatic and fiscal requirements are met.

Upon accepting this position, I assisted with one of the biggest grants Delaware Nation has ever received. The NTIA Broadband Grant for \$7,219,711.00. While many of the expenditures on this grant have been fulfilled, there are work activities that are still in progress.

GAMING COMMISSION

The Office of the Delaware Nation Gaming Commission is responsible for the integrity, security, fairness of operation, and administration of regulations for all of the Delaware Nation's gaming facilities. This is done by reviewing and approving all policies and procedures created by Lenape Entertainment, LLC, and enforcing all approved regulations and policies and procedures.

The Office of the Delaware Nation Gaming Commission is 100% funded by licensing fees.



1. Gaming Commissioner/Executive Director: Justin Pendarvis

- As the Gaming Commissioner, I am responsible for the approval of all: licenses; permits; policies and procedures; job descriptions; and internal audits.
- I'm responsible for ensuring the approved regulations are followed by all casino management and staff with the inclusion of issuing sanctions or taking license action for violations.
- I am also responsible for regulating the safety of employees, guests, and assets through facility inspections, utilization of surveillance, review of security incident reports, conducting site walkthroughs, and banning patrons from the facility.
- As the Executive Director, I am responsible for the day-today management of the Office of the Commission including financial planning, billing, record retention, personnel, and logistics. I'm also a liaison between government agencies and the operation and for LE's Compliance Department and issues concerning the Office of the Commission.
- I attended the 2022 NTGCR (National Tribal Gaming Commissioners and Regulators) Fall Conference in

- Currently, Ms. Botone is conducting her regular scheduled audits for the fiscal year.

4. Compliance Officers: Alixandrea Hubbard and Shannon Wetselline

- Ms. Hubbard and Ms. Wetselline typically split the responsibilities of compliance between the two casinos. They are responsible for testing electronic game software for compliance, breaking seals in sensitive areas of a slot machine, overseeing the installation and replacement of games as well as reviewing policies and procedures for compliance issues, conducting facility inspections and noting any violations and relaying information to the operation for correction.

4. Background Investigators (Employee Licensing): Regina McCarty and Leslie Halsey

 Ms. McCarty and Mrs. Halsey are the first lines of defense against those that would put the integrity of the casinos at risk from the inside. They conduct comprehensive background investigations on every employee to ensure that those people working for the Delaware Nation are not a risk to the gaming enterprises or the general public.



- Ms. McCarty and Mrs. Halsey both have continued to attend virtual webinar training presented by the NIGC pertaining to criminal justice information (CJI) and criminal history record information (CHRI).
- Mrs. Halsey recently attended the 2023 OTGRA (Oklahoma Tribal Gaming Regulatory Association) Spring Conference in Tulsa, Oklahoma.

5. Vendor Licensing Agent: Paula Pewo

- Ms. Pewo is responsible for conducting background investigations on all gaming vendors and non-gaming vendors as required by the NIGC and/or the Delaware Nation/State of Oklahoma Compact.
- For the fiscal year Ms. Pewo has processed approximately 303 files which are primarily renewals and new applications.

HOUSING

MISSION:

Housing Department's mission is to assist low income Native American families with affordable housing and other housing needs.

PROGRAMS:

LOW RENT PROGRAM AND LEASE TO PURCHASE PROGRAM: This program assists low-income Native American families with safe, decent and affordable housing with Delaware Nation citizens receiving preference. Eligible applicants are pulled from our waiting list when a unit becomes available. It is imperative for Delaware Nation citizens to apply and be added to the waiting list, if determined eligible. Household size listed on the application is an important factor used to determine if an available unit meets the applicant's household requirement.

TRIBAL RENTAL ASSISTANCE PROGRAM:

Delaware Nation Housing Department assists enrolled Delaware Nation citizens nationwide with Tribal Rental Assistance Program. Low-income eligible families are assisted with first time move in costs. These funds can be used to pay security deposits, first month's rent and utility deposits as long as funds are available. These funds cannot be used to pay existing utility bills or rent. All approved applicants must meet the 80% United States National Median Income Guidelines and must have a minimum annual income of \$15,600.00. Eligibility requirements and the application are on our Delaware Nation website.

The purpose of Delaware Nation's AOA program is to promote the well-being of older individuals (age 55 and older) by providing services and programs where they are treated with consideration, respect, and dignity. Quality and nutritious meals are served Monday through Friday to participants who come to the AOA building during the week from 11:30-1:00 pm. Sixty (60) home-delivered meals are provided Monday thru Friday, as well, to those who are unable to attend in person. There have been several activities provided during this year to allow elders to interact with each other in a fun atmosphere. 

CHR PROGRAM & PURPOSE:

Delaware Nation CHR paraprofessionals serve as an advocate for participants and provide basic health care, non-emergency transportation to medical appointments, periodic home health checks and health and disease prevention educational events for American Indians who are a member of a federally recognized tribe and reside within our tribal jurisdiction. There are no income guidelines required to participate in this service. Recording of assistance is entered into a secured system called Patient Care Components (PCC). This provides needed documentation on the effectiveness of our program and grant funds awarded.



VOCATIONAL REHABILITATION

PROGRAM:

Delaware Nation is currently in our 4th year of our 5-year grant for providing Vocational Rehabilitation (VR) Services. Our department serves 8 counties: Blaine, Caddo, Cleveland, Grady, Kiowa, Logan, McClain, and Oklahoma.

MISSION:

Our mission is to develop specialized services for American Indians with documented disabilities prepare for and engage in gainful employment. This is accomplished by developing an Individualized Plan for Employment (IEP)and providing guidance for each participant to reach each step of their plan.

SERVICES INCLUDE ASSISTANCE WITH:

- Transportation Assistance
- Clothing Assistance

PROGRAM DATA FOR OCTOBER 1, 2021 TO SEPTEMBER 30. 2022:

- Cases receiving services under an Individualized Employment Plan (IPE) that were shared with other tribal Vocation Rehabilitation programs: 20 %
- Cases receiving services under an IPE shared with the state Vocational Rehabilitation program: 95%
- Average wages at case closure for all cases closed successfully: \$495/wk
- Individuals who actively participated in an Individual Plan for Employment: 20
- Individuals enrolled in a training program (some are still actively pursuing their goal): 9
- Individuals who achieved an education goal: 2
- Individuals who achieved a "successfully employed" outcome (in their goal job for at least 90 days, and not experiencing barriers to employment due to their disability): 5

FACILITIES

Facilities is committed to providing quality maintenance and operational support for Delaware Nation. The staff has a service approach to maintenance providing timely response consistent with staffing and workload.


RESPONSIBILITIES:

- Provide weekly maintenance service for 9 buildings.
- Ensure the sanitation, health and safety standards are met for all buildings (i.e., sanitizing offices when needed; parking lot signs and painting; checking flooring issues, etc.).
- Maintain security and fire alarm systems in all buildings (i.e., fire extinguishers, fire suppression systems, smoke alarms, emergency exit signs, door locks, etc.).
- Maintain and oversee the outside property of all buildings (i.e., removing debris, mowing, planting & maintaining flower beds, hanging Christmas lights, etc.).
- Maintain Tribal vehicles (i.e., washing, detailing, oil & fluid changes, winterizing, and oversee scheduled maintenance appointments).
- Bidding & Overseeing large repairs (i.e., building renovations, heating and air equipment; roof repairs; plumbing problems; electrical issues, etc.).
- Assist with Tribal events by packing and moving equipment to event location and back to the Tribal Complex.
- Collaborate with other departments to assist when needed.
- Provide building pictures, building floor plans and maintenance cost per building for Self-Governance 105(l) Program application.

ELDER MOWING PROGRAM:

The Delaware Nation Facilities Department helps maintain the yards of fifteen (15) Delaware Nation elders. To qualify for this service, you must be an enrolled member of the Delaware Nation, 60 years of age or older and within a 40-mile radius of the Delaware Nation Complex. Services begin in May and run into August.

Facilities hires Summer Helpers each year, ages 16 to 21 years of age, who assist with this project. This gives our youth a chance to add work experience to their resumes, the ability to serve Elders and lets them earn money over their Summer break.

ENVIRONMENTAL PROGRAMS

MISSION:

Our mission is to protect the human health of our citizens as well as the environmental health of our jurisdictions, including promoting ecological diversity, fostering good relationships between people and the environment in which we live, and promoting best practices for conservation for our future generations.

GENERAL ASSISTANCE PROGRAM (GAP) HIGHLIGHTS:

- Collaborated with Community and Schools (CIS) to continue the Elimination of Single Use Plastic Program with the Anadarko High School. Aluminum Bottles were donated and a presentation on the effects of single-use plastic use was provided to the students.
- Collaborated with the City of Anadarko for the Great Anadarko Clean Up, April 17-22, 2023.
- Served as Region 6 (Oklahoma, New Mexico, Texas, Louisiana) Representative for the Tribal Science Council
- Served as Region 6 (Oklahoma, New Mexico, Texas, Louisiana) of the National Tribal Water Council (NTWC)
- Served as Secretary of the Tribal Environmental Coalition of Oklahoma
- Served as Secretary for the Caddo County Local Emergency Planning Committee (LEPC)
- · A member of the Caddo County Extension Council
- A member of the Emergency Management Tribal Partners in Southwest Oklahoma
- Awarded funding for Performance Partnership Grant (includes General Assistance Program and Clean Water Act 106) and Clean Air Act 103.
- Recently awarded the USDA Urban Agriculture and Innovation Production grant to finish work and expand the Lenape Gardens at the Local Food, Local Places area. This will include funding to install a greenhouse to promote food sovereignty and house our cultural plants. Funding will also be used to start an apiary and orchard, expand in-ground gardens, build the raised garden beds for ease of mobility, hold nutrition and gardening classes, and teach cultural knowledge with traditional plants from the greenhouse.
- Solid waste program collects recycling throughout the year and is taken to a processing facility in Lawton. GAP funding helps facilitate this collection. Delaware Nation Environmental Programs are currently seeking additional

funding for a large storage area, fork lift, and baler to grow the solid waste program further through the Solid Waste Infrastructure for Recycling Grant Program through EPA.

DELAWARE NATION WATER PROGRAM (DNWP):

- Oversees 13 water sites located along Sugar Creek, Cobb Creek, Spring Creek and Stinking Creek
- Performs Macro Invertebrate (bugs big enough to see with the naked eye and lacing a backbone) Collection biannually;
- Collects and tests for E. Coli bacteria during the warmer months at all locations;
- Tests the Total Phosphorus and Total Nitrogen nutrient levels at 10 of our sites year-round and outsources the samples to be tested in a lab;
- Delaware Nation was one of 12 tribes in the United States to be selected to join the ATTAINS pilot program and is currently an ATTAINS mentor for newly joined tribes.

DELAWARE NATION AIR PROGRAM (DNAP):

- Level 4 Emissions inventory is completed. The document will be available for viewing for tribal citizens by October 2023.
- Clean Air Act 103 Grant allows for outreach materials and development of a monitoring plan to fit the Nation's needs.
- The Air program will begin surveys in June of 2023 to assess Tribal Citizens' concerns regarding their air quality.
- The Air program maintains the Air Quality Index Sign located at the entrance of the Tribal Complex. This is to keep our citizens and community informed of the current Air Quality in our area.

OTHER TRIBAL ACTIVITIES:

- Provided a roll-off and tire collection for tribal citizens, April 17-21, 2023.
- Helped with clean-up during Delaware Nation Facilities
 Elder Clean-up Days during April 17-19, 2023
- Provided a Shred Event for tribal citizens and surrounding community, April 20, 2023
- Provided Electronic Waste Collection Event for citizens and the surrounding community from April 17-22, 2023.
 The amount of e-waste collected was incredible, so much that it had to be collected on a flatbed semi-truck trailer.
 Of that 1,953 pounds of TV were collected to be recycled as well as laptops, monitors, and towers.
- Helped with the 1-mile clean up on Highway 281 near the tribal complex on April 19, 2023. 75 bags of litter were collected by Delaware Nation staff.

Under the direction of the Tribal Administrator, the Public Relations Officer independently performs management-type duties associated with specific projects as assigned. The Public Relations Officer must be able to use all forms of media and communication to build, maintain and manage the reputation of the Delaware Nation ranging from public bodies or services to businesses and voluntary organizations, establish and maintain goodwill and understanding between the organization and its public, both in print and online.

Delaware Nation Public Relations facilitates all communication between the Nation and area news sources, tribal citizens, and any interested parties. The department's responsibilities include:

- Developing PR strategies and campaigns
- Preparing press releases and promotional material
- Assisting Directors in building positive relationships with stakeholders, media, and the public

As the Delaware Nation PR Officer, I will strive to maintain effective communication with the great citizens of Delaware Nation, using the best tools made available. I must report the facts and provide more ways to receive them. .

UTILIZING SOCIAL MEDIA TO REACH CITIZENS

Social media is a computer-based technology that facilitates the sharing of ideas, thoughts, and information through the building of virtual networks and communities. Facebook and Instagram are two very popular platforms so we utilize these tools effectively to reach a larger audience. As of 4/26/2023, Delaware Nation's Facebook Page has 4.3K followers!

MAINTAINING WEBSITES & TOOLS

Delaware Nation Public Relations maintains three websites:

Each website requires constant maintenance, security, and current informational updates to maintain a smooth and functioning experience for online users. As of April 2019, Delaware Nation's website is fully operated by the public relations department, saving thousands on contract services to build and maintain the Nation's website and posts. Also, having full control over the website allows for significantly faster news posts and information.

WEBSITE UPDATES

Delaware Nation's website has gone through many changes this year! The homepage has a new search bar, updated upcoming events calendar, more news plugins to fill the homepage with articles, made previous news articles easier to find when you navigate the "News" section, a "Service Programs" section was added and buttons created to make finding programs easier, added a "Frequently Used Forms" widget, added a "General Welfare Programs" widget, added a "Now Accepting Applications!" widget, privacy policy added, added a "Departments" section, changed the website layout background to white for legibility, and have maintained daily updates and bug fixes to keep the sites healthy. We are working on ways to create interactive submissions for new applications, as well as, ways to incorporate language tools that are being created through brand-new language preservation efforts. Our Children's Garden will soon feature a virtual tour that will allow guests to see the entire facility when they visit dneclc. com. Dirt Road Graphics was completely revamped for better functionality and less downtown with old theme layout bugs. The purchasing process is easier than ever and a pick-up option has been added in the checkout section! A privacy policy was created to give the buyers the ease of knowing that their data isn't being breached.

MASS TEXT SERVICE

Delaware Nation Public Relations maintains contact with employees and tribal citizens with an SMS text messaging service called Textedly. This application sends mobile phone users important information regarding closures and current events quickly and efficiently. To opt-in, text the keyword LENAPE to phone number 77222. It's that simple to stay informed and connected! Delaware Nation sends an average of 4 messages per month and you can opt-out by simply replying STOP. Message and data rates may apply. This service is also utilized with "Our Children's Garden" Me-Mun-See Hah-Kee Hah-Kun early childhood learning center.
